### ***The TIM Quarterly Review—A New Way of Reaching Out***

Welcome to the first edition of the *TIM Quarterly Review*, the newsletter of the District Six Traffic Incident Management (TIM) Team. The TIM program is sponsored by the Florida Department of Transportation (FDOT) to provide an efficient incident response plan that improves overall mobility along our regional roadways. The District Six TIM Team serves as the facilitating medium between the Department and its partner agencies to provide appropriate multi-jurisdictional responses to traffic incidents and

transportation events.

In its continuing effort to improve program initiatives, the TIM Team is focusing on direct agency-to-agency outreach in Fiscal Year 2009/2010. With several programs set to launch within the next few months, enhancing communication and establishing appropriate response procedures will serve to improve overall coordination once these programs are deployed. Serving to further enhance this approach, the TIM Team developed the *TIM Quarterly Review* newsletter to keep partner agencies informed of new and

on-going TIM activities throughout the year. This quarterly newsletter will serve as the information exchange forum between the Department and its partners.

### District Six Gets Ready for Hurricane Season

The District Six Transportation Management Center (TMC) is preparing for the upcoming Hurricane Season by deploying a redundant operations system that will serve as a “back-up” TMC in case a major storm or emergency affects regular operations. As part of the TMC Hurricane Response Action Plan (HRAP), the back-up facility is located in the District’s Adam Leigh Cann building, and is equipped with the necessary software

to manage traffic, respond to incidents and communicate with partner agencies. A plan outlining system procedures has been developed, and key staff members are being trained to ensure system operations is maintained before, during and after an emergency situation. Testing of this back-up location is set to begin in the coming weeks, and final system deployment will be ready in time for Hurricane Season, on June 1st, 2009.
